Rules and Policies

- Tournament management reserves the right to modify, combine, or cancel events, limit total participants, total entries by event, and or move the league date for unforeseen reasons. If event is cancelled the fees for this event will be refunded.
- All matches are best 2 out of 3 games and/or 3 out 5 games based on total number of participants. All games are to 11 points with a difference of 2.
- No prizes will be awarded to players for splits, defaults, dumps and no-shows. Default time is Event / Match start time which is 1:30 pm on Saturdays. All matches must be completed on the same day.

- **Tournament style Two Stage RR+SE:**
 - **Stage 1:** RR Groups of 4 to 6 players.
 - **Stage 2:** SE Rounds of 8-12 players per division
- The most recent Spindex ratings will be used for seeding the players for each week
- Players whose ratings get manually adjusted during season or compromised ratings after first weeknight of the league will be automatically disqualified from winning awards and prize money for rest of the season including monthly and seasonal awards.
- *Note: Tournament committee reserves the right to deny prize money and/or awards to sandbagging players*
- Seasonal awards will be provided based on the combined results from all 6 weeks. Ties will be broken down using existing USATT rules across all matches played over 6 weeks.
- Seasonal Awards are provided for players who participate across all 6 weeks for two categories, most matches played and most improved players
- Top 3 Most Matches played (opponent defaults, no shows don't count) from www.stadiumcompete.com stats will be used
- Most Improved Player Awards: For players who participate across 5-6 weeks, the top 3 most improved players on Spindex Ratings and Ranking points from week 1 to Week 6 will be awarded. (League reserves the right to disqualify player and/or matches in Spindex system which look like an anomaly for awards). Ranking Points awarded across all divisions every week Winner: 30 points Runnerup:18 points Semi Finalist: 12 points Quarter finalist:8 points Round of 16:6 points and group stage participants 4 points. The final awards will be based weighted average of Spindex improvement and Ranking points.
- Players must register at the desk or check in online at stadiumcompete.com no later than 90 minutes before start time.
- Pre-match warm-up will be limited to 2 minutes.
- All events will be round robin in groups of 4-6 players if possible.
- Unrated players will be given an estimated rating based on a recommendation by a coach who knows the player or by visual evaluation of the player by a coach, whenever possible. Unrated players may not win prize money or Awards except for the top division.
- Withdrawals through January 15th, 2026, will be eligible for full refunds.
- Any image, photographic, video or otherwise, taken of the tournament play or within the official venue is essentially the property of CITTA (Chicago International Table Tennis Academy). Entrants agree to allow their picture, video, voice and likeness to be reproduced in connection with CITTA or by way of any medium.
- USATT Dress Code applies. The main body of the shirts, shorts and skirts must be significantly different than the color of the ball. **White shirts, shorts and skirts Not allowed.**
- All USATT regulations apply. Only USATT approved equipment will be used: 10 blue Butterfly Centerfold Table Tennis Table and Joola White 3-star Premium 40 + plastic balls
- **For matches to be counted for the league results and standings all league balls must be returned to CITTA by respective players from Groups and Divisions playoffs**
- Purchase of Seasonal pass and/or weekly pass is not guaranteed for a spot to play in the league. Seasonal and weekly league pass holders still need to sign up for each week at least 24hrs before start time and check in at least 1hr before play begins. 1hr before league starts registration and checking will close online. Open Spots will be filled based on first come first serve basis for players at the venue. Open Spots will be filled up by players who are waiting at the venue within 1 hr. of league play start time.
- Season and Weekly passes are not transferable to another individual and cannot be applied or carried on to a different Season.
- Season passes are not refundable. Weekly passes are not refundable after Thursday of the respective league week.

LEAGUE PARTICIPANT WAIVER

IN CONSIDERATION of being permitted to participate in any way in USA Table Tennis affiliated club events, I and/or minor child, our personal representatives, assigns, heirs, and next of kin, I:

ACKNOWLEDGE, agree, and represent that I and/or minor-aged child understand the nature of Table Tennis Activities, including but not limited to risks involved in the sport itself together with all risks, known and unknown, associated with gatherings of people ("Activities"), including the exposure to COVID-19, coronavirus, or other infectious organisms or diseases; and that I and/or minor child are qualified, in good health, and in proper physical condition to participate in such Activities. I further agree that if at any time I believe conditions or equipment to be unsafe, I and/or minor child will immediately discontinue further participation in the Activities.

FULLY UNDERSTAND that (a) TABLE TENNIS ACTIVITIES INVOLVE RISKS AND DANGERS OF SERIOUS BODILY INJURY, INCLUDING PERMANENT

DISABILITY, PARALYSIS, DISMEMBERMENT, AND DEATH ("RISKS"); (b) these Risks and dangers may be caused by me and/or minor child's own actions, or inaction, or the actions or inaction of others participating in the Activities, the condition in which the Activities takes place, or THE NEGLIGENCE OF THE "RELEASEES" NAMED BELOW; (c) there may be OTHER RISKS AND SEVERE SOCIAL AND ECONOMIC LOSSES either not known to me or not readily foreseeable at this time; and I FULLY ACCEPT AND ASSUME ALL SUCH RISKS AND ALL RESPONSIBILITY FOR LOSSES, COSTS, AND DAMAGES I and/or minor child incur as a result of my participation in such Activities.

I swear and affirm that I am in good physical condition, and I am not aware of any previous or existing diseases or injury that would result in my being injured. I further acknowledge that I have procured on my own and currently hold valid and adequate insurance for such loss, damage, or injury and if I do not have valid and adequate insurance, I accept full responsibility for the cost of the loss, damage, or injury that might occur as a result of my participation in this table tennis tournament. I give my consent to participate in all emergency transportation associated with activities during this table tennis tournament, in the event I become incapacitated or otherwise not conscious to give direct consent and I accept full responsibility for all costs associated with all emergency transportation as deemed necessary. Further, as the parent/guardian of a participating minor athlete, I hereby give my consent for complete medical treatment and

emergency transportation services as deemed necessary beyond the on-site athletic trainer or emergency medical treatment provided.
