#### **ELIGIBILITY:**

Players for rated events must be a member of the USATT.

### **TOURNAMENT RULES:**

- This tournament is rated as a 3-star event.
- Format for all events is Round-Robin only or Round-Robin + single elimination based on number of entries.
- EQUIPMENT: Gewo tables and Gewo white 40+ balls.
- For all junior events, players must be under the event age on tournament date
- All ITTF and USATT rules dress code apply.
- All matches are best of 5 games.
- All players must report to the control desk 20 minutes prior to the start time of their event.
- No scheduled lunch break will be observed. Default will be the result if players have left the tournament site without permission of the Tournament Director or Control Desk.
- The rating posted on the USATT website as of the entry deadline will be a participant's rating.
- Unrated players are not permitted to advance beyond the preliminary round robin stage. However, they may be evaluated by a tournament-designated coach or professional to receive an estimated rating. Once assigned, this rating may allow the player to advance beyond the preliminary stage.
- Topspin Table Tennis Club is fully compliant with SafeSport standards.

- 1. IN CONSIDERATION of being permitted to participate in any way in USA Table Tennis sanctioned events, I and/or my minor child, our personal representatives, assigns, heirs, and next of kin:

ACKNOWLEDGE, agree, and represent that I and/or my minor understand the nature of Table Tennis Activities and that I and/or my minor child are qualified, in good health, and in proper physical condition to participate in such Activity. I further agree that if at any time I believe conditions or equipment to be unsafe, I and/or my minor child will immediately discontinue further participation in the Activity.
- 3. FULLY UNDERSTAND that (a) TABLE TENNIS ACTIVITIES INVOLVE RISKS AND DANGERS OF SERIOUS BODILY INJURY, INCLUDING PERMANENT DISABILITY, PARALYSIS AND DEATH, HARASSMENT, EXPOSURE TO INAPPROPRIATE CONDUCT AND LANGUAGE ("RISKS"); (b) these Risks and dangers may be caused by me and/or my child's own actions, or inaction, or the actions or inaction of others participating in the Activity, the condition in which the Activity takes place, or THE NEGLIGENCE OF THE "RELEASEES" NAMED BELOW; (c) there may be OTHER RISKS AND SEVERE SOCIAL AND ECONOMIC LOSSES either not known to me or not readily foreseeable at this time; and I FULLY ACCEPT AND ASSUME ALL SUCH RISKS AND ALL RESPONSIBILITY FOR LOSSES, COSTS, AND DAMAGES I and/or my minor child incur as a result of my participation in the Activity.
